# Pact Act Passes

"WASHINGTON — A bill enhancing health care and disability benefits for millions of veterans exposed to toxic burn pits won final approval in the Senate on Tuesday (August 2, 2022), ending a brief stalemate over the measure that had infuriated advocates and inspired some to camp outside the Capitol.

The Senate approved the bill by a vote of 86-11. It now goes to President Joe Biden's desk to be signed into law. He has said the bill "makes good on our sacred ob-ligation" to care for veterans and their families.

The Senate had overwhelming approved the legislation back in June, but a do-over was required to make a technical fix. That process derailed when Republicans made a late attempt to change another aspect of the bill last week and blocked it from advancing.

The abrupt delay outraged veterans groups and advocates, including comedian Jon Stewart. It also placed GOP senators in the uncomfortable position of delaying the top legislative priority of service organizations this session of Congress.

The legislation expands access to health care through the Department of Veterans Affairs for millions who served near burn pits. It directs the VA to presume that certain respiratory illnesses and cancers were related to burn pit exposure, allowing veterans to obtain disability payments to compensate for their injury without having to prove the illness was a result of their service.

The bill is projected to increase federal deficits by about \$277 billion over 10 years."

Editors Note:

A member contacted us and asked if we could do something about the initial failure of the act. After contacting Senator Crapo's and Senator Risch's office, here is what we found:

According to Senator Crapo's office, the reason he voted "no" was because the wording in the Pact Act allowed up to **\$400 Billion dollars** unrelated to veterans issues be spent. Senator Risch said the same thing in a statement on August 3, 2022 for Channel 7 News. Note the difference in the dollar amounts.

Senator Crapo and Senator Risch were two of the 11 "NO" votes on the final passage of the Pact Act.

Many of our programs will begin to spin up in September. Included is the Oratorical Contest, and SAL. Please plan on supporting these programs.



### **National Coast Guard Day**

Dog Days of SUMMERs



The first national holiday of the month, August 4th, is dedicated as National Coast Guard Day. On this day in 1790, the US Coast Guard was founded as the Revenue Marine by then-Secretary of the Treasury, Alexander Hamilton. The Coast Guard received its present name through an act of Congress signed into law by President Woodrow Wilson on

January 28, 1915. This act merged the Revenue Cutter Service with the U.S. Life-Saving Service and provided the nation with a single maritime service dedicated to saving life at sea and enforcing the nation's maritime laws.

### **Purple Heart Day**



August 7th is Purple Heart Day. The Purple Heart was first created on August 7, 1782 by the Commander-In-Chief of the Continental Army, General George Washington. Then known as the Badge of Military Merit, it was awarded to three Revolutionary soldiers in 1783. It wasn't until 1932 that the metal was revived on the bicentennial anniversary of George Washington's birth. The Purple Heart is a U.S. military decoration

awarded in the name of the President to those wounded or killed while serving on or after April 5, 1917. It is the oldest military award still given to U.S. military members.

Consistent with the ongoing approach to site deployment readiness, **VA decided not to move forward with go-live of the new EHR at Boise VAMC this weekend.** The decision was made jointly with VHA stakeholders including site and VISN leadership.

VA is doing everything possible to ensure safe and successful deployments. Adjustments to the go-live schedule and other important considerations simply reflect this due diligence. Patient safe-ty and burden on our medical personnel are foremost on our minds.

While the Boise VAMC and EHRM-IO staff worked tirelessly to get us to this point and there are positive improvements in many areas, in assessing Boise's readiness for deployment this weekend, VA made the decision that, at this point, additional improvements need to still be made to ensure a safe and successful deployment. VA continues to work with Oracle Cerner to put important system enhancements in place and make the necessary improvements to ensure system stability.

The next scheduled deployment is January 28, 2023, in Saginaw and Ann Arbor, MI. During this short interim, VA will not be idle, there is much work to do as we head into the busy schedule during CY 2023.

The EHRM program office anticipates scheduling future sites based on lessons learned and current EHR implementations to ensure the department is moving forward in a safe and efficient manner.

Thank you for your continued patience and flexibility as the program matures – and, importantly, for all that you continue to do to advance this historic effort on behalf of our nation's Veterans.

# American Legion Post 113 Service Officer Announcements

The following summarizes the July 2022 Service Officer announcements for American Legion Post 113:

### Sign in to My HealtheVet for Boise VA Users Changes on July 23

Are you are receiving health care from the Boise VA? Beginning on Saturday, July 23 users of My Healthe-Vet (MHV) will be required to migrate to My VA Health portal. If you get stuck trying to access the new portal call the MHV Help Desk 877/327-0022. Please be advised you must continue to use the My HealtheVet patient portal to request prescription refills or renewals for medications ordered by VA providers from other VA medical facilities that are not using the new VA's EHR system. In addition, if you had VA health care from other VA facilities you will need to continue using MHV to access those records. The VA states this new process gives your account an extra layer of security to keep your VA information safe.

### Tricare Dental Care Bill for Our Military Reserve and Guard Troops is Stuck

A bipartisan bill (H.R. 8113) to waive premiums and co-payments for National Guard and Reserve Servicemembers under the TRICARE Dental Program, with the goal of improving military readiness by reducing the number of nondeployable servicemembers doesn't yet have the support it requires from Congress. A study of reserve component servicemembers who served during Operation Enduring Freedom put their rates of dental health issues twice as high as their active-duty compatriots. The National Guard Association of the United States, the Reserve Organization of America (ROA) and Military Officers Association of America (MOAA) all support this bill.

### The PACT Act (Promise to Address Comprehensive Toxics Act)

This Act was passed by the US House in March 2022 and with some changes by the Senate in June. In both chambers of Congress, it had broad bipartisan support. But now it's back in the House again for some final revisions. This bill is a comprehensive solution to provide access to VA health care and benefits for toxic-exposed veterans. It helps veterans by establishing a permanent presumptive framework to address toxic exposure, foreign or domestic, past, present, and future. #### 988 Suicide and Veterans Crisis Hotline Launched on July 16

This is a new law that requires all U.S. telephone service providers to activate 988 by July 16. Now multiple suicide prevention hotlines are united under the 988 number including the VA's Veterans Crisis Hotline. However, you can still call the VA 10-digit Veterans Crisis Hotline assuming you can remember that number. The VA's 2021 National Suicide Prevention Annual Report states 6,261 veterans died by suicide in 2019. Firearm deaths accounted for more than 70% of veteran suicides that year. In 2020 during the pandemic military suicides increased by 16%. Suicide rates across the DoD continue to rise at an alarming rate. A shortage of personnel from reductions to end strength will likely exacerbate the problem where troops must do more with less. To help combat these concerns, the House Personnel Subcommittee included authorization for two weeks of temporary duty (TDY) each year for wellness to attend a seminar or retreat, including outdoor events with nonprofit organizations to improve resilience and psychological wellness. Recent spikes in suicides such as those reported among the crew of USS George Washington (CVN-78) and a similar cluster in Alaska have drawn the attention of the media and Congress.

A Victory for Veterans The U.S. Supreme Court issued a victory not just for veterans but for our entire nation. The Court ruled in Torres versus Texas that a former state trooper had the right to sue his state after it refused to re-hire him following a military deployment. Le Roy Torres was an officer with the Texas Department of Public Safety until he was called to active duty in 2007. While in Iraq, he was exposed to burn pits and returned home suffering from constrictive bronchitis. Though his respiratory condition prevented him from working again as a state trooper, the agency refused to offer an accommodation and place him in an alternative position. Normally, sovereign immunity protects states from paying damages to its citizens. However, then-Justice Stephen Breyer, pointed out the responsibility that all states have in supporting the efforts of our military, *"In joining together to form a Union, the States agreed to sacrifice their sovereign immunity for the good of the common defense"*. https://www.legion.org/

commander/256236/supreme-victory-veterans **Pension Poaching** Veterans, survivors and their families who are potentially eligible for VA pension benefits are being defrauding by scammers. If you currently receive a VA pension or are thinking about applying for one know how to avoid these scams. They are individuals and organizations who claim to be your advocate, and claim they can help you gain more VA benefits than you may be already receiving. Who should you trust? You should never pay for any assistance when applying for VA benefits. Accredited Veteran Service Organization (VSO) representatives provide free advice and help complete and file VA applications. These certified professionals are trained

to support you and your family while costing you nothing. https://blogs.va.gov/VAntage/105618/pensionpoaching-learn-to-spot-scammers-and-who-you-can-trust-for-support/ Another Delay for the VA's EHR Veterans Affairs officials will delay deployment of their new electronic medical records system to additional sites until 2023 to ensure "adequate reliability," officials confirmed to Military Times. The move comes after repeated concerns from Congress about ongoing problems with implementation of VA's Oracle Cerner Millennium software platform, the same records system being installed by the Department of Defense at its medical sites. Lawmakers were informed of the delay on June 17. Department officials had planned to deploy the software at the Puget Sound VA Health Care System (American Lake and Seattle VA Medical Centers) this August, but will now delay that work until March 2023 instead. In addition, plans to deploy the platform to the VA Portland Health Care System (Portland and Portland-Vancouver VA Medical Centers) will shift from this November to April 2023. "In evaluating [the sites'] readiness for deployment, VA determined the system hadn't shown adequate reliability to support the current schedule," officials said in a statement. "The date was changed to allow Oracle Cerner to put important system enhancements in place and make the necessary improvements to ensure system stability ... as well as fix outstanding issues to address research workflow challenges." Steps already underway to deploy the system to VA sites in Idaho in July 2022 will remain unchanged, officials said. The 10-year, \$16-billion electronics health records overhaul has faced numerous delays in the past few years, both because of pandemic complications and implementation problems at initial rollout sites. When then-President Donald Trump announced the plan in 2017, the goal was to provide a seamless, lifelong medical record for service members starting from their day of enlistment through their post-military life. But putting the system into place at VA has proven challenging, with numerous problems and frustrations emerging from the initial rollout of the system at Mann-Grandstaff VA Medical Center in Washington in 2020. Last summer, VA Secretary Denis McDonough ordered a halt to the work so officials could evaluate and correct challenges that emerged there. But three months ago, the VA Inspector General's Office said that serious safety issues regarding patient medications and mental health 19 flags remained unresolved with the new system. VA planners deployed the system to the Central Ohio Healthcare System in May, the third site so far in the implementation process. Department leaders said that work has progressed on schedule, and the delay of the other sites is not indicative of problems there. But they acknowledge that "there have been unanticipated outages and system degradations from the onset of the new [health records] rollout" so far. "Between major deployments VA will continue to work vigorously to ensure that the system has the capability enhancements and is optimized to support deployment [at future sites]." Department leaders also said they are committed to "safe and successful deployments" and the changes in deployment schedules are designed to prevent potential problems in the future. 3

VA's Commitment to long-term COVID Care About one half million veterans who receive care from the Department of Veterans Affairs believe they have had COVID-19, and one of about 23,000 veterans have been confirmed with a long-term COVID diagnosis, according to VA press secretary Terrence Hayes. Long-term COVID, also known as long-haul COVID or post-COVID-19 condition, can be wildly different for patients. Symptoms may range from difficulty breathing to muscle aches to other serious conditions, including mental health disorders and suicidal thoughts, that may last weeks, months or longer. While the VA is still trying to figure out whether veterans will face a heavier burden, and whether toxic exposures or the toll of combat will add to the list of conditions exacerbated by service, thousands of former troops have participated in VA research that demonstrated veterans with long-term COVID are at an increased risk of other serious illnesses. They are subsequently receiving treatment through a patchwork of 17 VA long-term COVID care programs, which offer a range of treatment options that parallel disparate practices being used in non-military medical networks. These diverse VA programs, some fully online and some entirely in-person, differ in part because medical researchers are still trying to solve the puzzle of the science behind long-term COVID. How successful they will be in helping combat the lingering effects of COVID among veterans is still very much in doubt in what are still the early stages of the fight against long-term COVID. https://www.survivorcorps.com/pccc https://blogs.va.gov/VAntage/105381/

Articles of Incorporation: Article VIII, Section 5. POWERS AND DUTIES OF THE CHAIRMAN AND VICE CHAIRMAN. The Chairman shall preside at all meetings of the Board of Directors and Subchapters, shall enforce observance of the Articles of Incorporation and Bylaws, shall have the right to vote on all motions, shall appoint members to committees, and shall have such powers and duties as the Board may prescribe including that of serving as official spokesman on behalf of the Board of Directors.
