2. "Easter – A Major Christian Holiday"





2023 IDAHO VETERAND PARADE

November 4, 2023, 10:00-12:00

Proposed Parade Routes

Please review the following for discussion prior to March 10, 2023. Your comments will be reviewed at the parade committee meeting on March 14, 2023.

Three options are presented for your consideration:

Option 1 - No Change

Option 2 – 5th Street to VAMC

Option 3 – ISVH-Boise to Ft Boise Park

Option 1 is not illustrated and is defined as the existing parade route to include the existing staging plans, opening ceremony site, television broadcast layout, parade administration infrastructure, route, barrier plan and exit plan.

Option 2 proposes a change to the route and end point only. This route provides the inclusion of the Road of Honor along the South Loop Road of the Veterans Administration Medical Center (VAMC) and brings the parade to the residents building of both the VAMC and the Idaho State Veterans Home – Boise. Additional benefits include a reduction of parking restriction as an improvement in space available for public viewing of the parade as well as enhancements of demonstration areas and the historic Boise Barracks sites.

Permission was obtained for this route from the Veterans Administration for 2022 but the parade committee decided additional planning would be benifitial and the 2022 parade remained within the established route.

Option 3 proposes a complete rearrangement of all aspects of the parade as shown in the attached illustration. This option centers the parade around the VAMC and other federal and public properties with no need for parking restrictions other than the area south of Ft. Boise Park that must be kept clear for parade traffic. Ft. Boise Park and VAMC paradeground offer ideal spaces for public particiation in adjunt activities such as demonstrations, concerts, and other large group activities associated with the celebration.

Close coordination with the VAMC, ISVH-Boise, Boise Park and Recreation has the potential to transform the existing 2 hour parade into a weekend long patriotic celebration with activities such as the following:



LLOYD HUTCHESON GIVES LIFE ON FRENCH SOIL

Lived in Meridian All His Life; Memorial Services Largest Ever Held Here.

MERIDIAN--Lloyd Hutcheson, Meridian's first son to be killed in action in France, laid down his life on the fields of France on June 19. Word was received by his mother Mrs. L. E. Hutcheson on Saturday, July 6 from the war office. Memorial services were held in the First Methodist church of Meridian Sunday evening, July 7. The largest crowd in the history of Meridian turned out to pay their respects to the memory of the young man.

Lloyd Hutcheson and Miss Fern Parker were married just before the Idaho boys left Boise for France. Lloyd was a member of the old company H of the 2nd Idaho. At the time of his death he was a member of E company of the 2nd engineers, A. E. F. He served on the Mexican border and in northern Idaho.

Hutcheson was born January 4, 1895 in Boise valley and was 23 years old at the time of his death. He lived practically all his life in Meridian.

Hutcheson carried an insurance policy for \$10,000 which was made out in favor of his mother.

The PACT ACT for a Surviving Spouse

The surviving spouse of a deceased Vietnam era veteran that experienced a herbicide presumptive condition who served in any of the new PACT Act locations, such as Laos from December 1965 through September 1969, may file a claim for Dependency Indemnity Compensation (DIC) for one of those conditions even if the veteran did not file for that condition while they were alive. If a veteran was previously denied for one of the herbicide presumptive conditions from service, then a Supplemental Claim must be filed citing the PACT Act being signed into Law on August 10, 2022, as the new and relevant evidence will be needed for the supplemental claim. Please contact me if you have questions about this or know of a surviving spouse that may qualify for this type of claim

Changes to VA Health Care under PACT Act

Veterans should go to VA.gov/PACT to learn about what the PACT Act bill means for them and their families. Veterans who did not previously enroll in VA health care have a 1-year window to enroll if they:

Served on active duty in a theater of combat operations during a period of war after the Persian Gulf War,
 or

- Served in a combat against a hostile force during a period of hostilities after Nov. 11, 1998, and
- Were discharged or released from active service between Sept. 11, 2001, and Oct. 1, 2013.

Veterans who served on active duty in a theater of combat operations during a period of war after the Persian Gulf War will be eligible for care. This includes veterans who, in connection with service during such period, received the Armed Forces Expeditionary Medal, Service Specific Expeditionary Medal, Combat Era Specific Expeditionary Medal, Campaign Specific Medal, or any other combat theater award established by federal statute or executive order.

What Does the PACT Act mean for Vietnam Era veterans?

For Vietnam Era veterans, the PACT Act expands beyond the herbicide presumptive conditions to include:

- Hypertension (High Blood Pressure).
- Monoclonal gammopathy of undetermined significance (MGUS) which is a precursor to Multiple Myeloma.
- It also expands the locations where veterans who served during Vietnam are considered exposed to herbicides to include:
- Any U.S. or Royal Thai military base in Thailand from January 9, 1962, through June 30, 1976.
- Laos from December 1, 1965, through September 30, 1969.
- Cambodia at Mimot or Krek, Kampong Cham Province from April 16, 1969, through April 30, 1969.
- Guam or American Samoa, or in the territorial waters off of Guam or American Samoa from January 9, 1962, through July 30, 1980.
- Johnston Atoll or on a ship that called Johnston Atoll from January 1, 1972, through September 30, 1977.

If a Veteran served in any of the above locations and has passed from a presumptive service connected condition, the surviving spouse may file a claim for Dependency Indemnity Compensation (DIC) for one of these conditions even if the veteran did not file for the condition while they were alive.

Expansion of Program of Comprehensive Assistance for Family Caregivers (PCAFC)

The PCAFC provides caregivers of eligible veterans with resources, education, financial assistance, health insurance, beneficiary travel, peer support, etc. The PCAFC has been expanded to include eligible veterans and family caregivers of all eras. Previously, PCAFC was only available to eligible veterans who served on or after September 11, 2001. This expansion opens the program to eligible veterans of all eras, including those who served after May 7, 1975, and before September 11, 2001.
