**February: A Month Steeped in Military History By** Ralph Cavalieri

For American Legion Post 113 members, February isn't just the shortest month; it's a time to remember the sacrifices made throughout history. From pivotal battles to acts of courage, significant military events echo through the annals of this month. Here are a few:

- **February 3rd, 1944:** This day marked the beginning of the "Four Chaplains" story. U.S. Army Chaplains Alexander Goode (Methodist), John Washington (Catholic), Clark Poling (Protestant), and Rabbi Robert Katz offered comfort and prayers to soldiers aboard the sinking USAT Dorchester during World War II. When life rafts became available, the chaplains refused to take their places, prioritizing others and sacrificing themselves in the icy waters. Their selfless act embodies the spirit of service and remains a powerful symbol of interfaith unity.
- **February 15th, 1898:** The mysterious explosion of the USS Maine in Havana Harbor, Cuba, sent shockwaves through the nation. 260 sailors lost their lives, igniting public outrage and fueling anti-Spanish sentiment. Though the cause remains debated, the "Remember the Maine!" cry became a rallying cry, ultimately leading to the Spanish-American War. This event serves as a reminder of how historical events can be shaped by national grief.
- February 24th, 1991: After weeks of air assaults and ground offensives,
   Operation Desert Storm culminated in a decisive victory for the U.S.-led coalition
   forces, liberating Kuwait from Iraqi occupation. This 100-hour ground war
   showcased the advancements in military technology and strategy, but also the
   human cost of conflict. February 28th marked the official ceasefire, a day etched
   in the memories of veterans who fought for freedom.
- **February, continuously:** Beyond specific dates, February recognizes Black History Month, honoring the contributions of African Americans in the armed forces. From the Revolutionary War to present day, African American service members have bravely defended our nation, facing unique challenges and discrimination. Their stories deserve recognition and inspire continued efforts for equality and inclusion.

As we reflect on these historical moments, let us also remember the countless others whose sacrifices shaped the course of military history. Their courage, resilience, and commitment to duty serve as enduring lessons for future generations. We, at American Legion Post 113, carry their legacy forward, honoring their service and advocating for those who continue to serve.

#### It's Not About Me – Dan Pruett

Embracing "It's Not About Me" Together

My name is Dan Pruett, and I proudly stand as a member of the American Legion. Allow me to share something profound that has reshaped my life: the simple yet profound statement, "It's not about me."

I would like to announce a program on "It's not about me"? I would like to explain the program.

This phrase holds a depth of meaning—it signifies that we, personally, are not the focal point of existence. It signifies a mission larger than self, a purpose beyond personal desires. It means prioritizing others, especially those who've dedicated themselves to serving our nation.

Let me recount a moment that encapsulates this notion. While serving as an E-6 in the navy, attached to a VAW squadron, an incident during preparations for an "ALPHA STRIKE" on Tiger Island altered everything. It was 0830 hours January 21, 1969, aboard the USS Enterprise in Hawaiian waters. The magnitude of that moment shifted my world in a fraction of time.

Amidst the launch preparations, an explosion cascaded chaos—planes laden with rockets, napalm bombs, and "Agent Orange" were set ablaze. My instinct and Navy training kicked in. Amidst the fiery chaos, I witnessed the selflessness of individuals, regardless of their rank or rate, striving to douse the flames. I recall aiding a fellow, engulfed in napalm, to the makeshift Triage area on the ship's front. Seeing the tragedy unfold had a mind-numbing effect on me. That day, over 125 valiant souls sacrificed themselves for the safety of others.

The aftermath haunted me with nightmares, depression, and PTSD upon returning home. However, fate led me to the American Legion, where I found solace among fellow veterans. They reminded me that life still held meaning – "It's Not About Me"; it's about supporting our veterans, advocating for their rights, and being their voice.

This story is just one of many shaping my values – a commitment to serving, loving, and honoring others, prioritizing service above self. It echoes the core values of the American Legion—freedom, democracy,

justice, loyalty, courage, and honor, and aiming to leave a legacy for future generations.

I wear a silicone wristband inscribed with "It's not about me." When I start to falter, I snap it against my wrist, and it realigns my focus.

Here at the Post 113, we have countless opportunities to show our support for our veterans. Everything we do here requires volunteers to help support those endeavors. Participation is the key to being a legionnaire. We must volunteer our time towards the goals of the American Legion. It's like the old saying 20% of the people do 80% of the work. That, my friends, leads to burn out and withdrawal from the meetings and activities of those few who volunteer here the most at the post.

So, the next time we do something that requires a small amount of your time please volunteer and think about why we are doing what we do. It is for the greater good. Just an hour or two a month would help tremendously.

#### American Legion multiyear membership is here.

Eliminate the yearly hassle of remembering to renew your American Legion membership by taking advantage of the new multiyear membership available to current and potential members. Legionnaires needing to renew for 2024 or veterans joining the organization for the first time can lockin a three-year membership by visiting <a href="legion.org/renew">legion.org/join</a>. It's a five-year pilot program offering the purchase of three consecutive 12-month member terms at the then current dues rate.

#### Here is what you need to know about the three-year membership:

- Multiyear membership sign-up is only available on the national American Legion website.
- Renew now with a three-year membership by visiting <u>legion.org/renew</u>.
- Join now with a three-year membership by visiting legion.org/join.
- Legionnaires already renewed for 2024 will soon be able to renew under the multi-year membership starting with the 2025 membership year.
- Payment for the three-year membership will be upfront.

<u>Please note</u>: the multiyear membership will work just like PUFL. Whatever rate the member renews at is the what the post/department/national will receive for the duration of that timeframe. Once the member renews after the three-year renewal is up, the renewal rate will adjust to the rate at that time.

GRENADA INVASION 1983, A SHORT WAR NOT MANY ARE AWARE OF

The **United States invasion of Grenada** began at dawn on 25 October 1983. The <u>United States</u> and a <u>coalition</u> of six Caribbean nations invaded the island nation of <u>Grenada</u>, 100 miles (160 km) north of <u>Venezuela</u>. Codenamed **Operation Urgent Fury** by the U.S. military, it resulted in military occupation within a few days. It was triggered by the strife within the <u>People's Revolutionary Government</u>, which resulted in the house arrest and execution of the previous leader and second <u>Prime Minister</u> of Grenada, <u>Maurice Bishop</u>, and the establishment of the Revolutionary Military Council, with <u>Hudson Austin</u> as chairman. The invasion resulted in the appointment of an interim government, followed by <u>elections in 1984</u>.

Grenada had gained independence from the <u>United Kingdom</u> in 1974. The <u>Communist New Jewel Movement</u> seized power in a nearly bloodless <u>coup</u> in 1979 under <u>Maurice Bishop</u> suspending the constitution and detaining several political prisoners. In September 1983, an internal power struggle began over Bishop's leadership performance. Bishop was pressured at a party meeting to share power with Deputy Prime Minister <u>Bernard Coard</u>. Bishop initially agreed, but later balked. He was put under house arrest by his own party's Central Committee until he relented. When his secret detention became widely known, Bishop was freed by an aroused crowd of his supporters. Bishop made his way to the army headquarters at Fort Rupert (known today as Fort George). After he arrived, a military force was dispatched from Fort Frederick to Fort Rupert. Bishop and seven others, including cabinet ministers, were captured. Then a four-man People's Revolutionary Army firing squad executed Bishop, three members of his Cabinet and four others by machine-gunning them.

The Reagan administration mounted a US military intervention following receipt of a formal appeal for help from the Organization of Eastern Caribbean States, which had received a covert appeal for assistance from the Governor-General of Grenada, Paul Scoon (though he put off signing the formal letter of invitation until 26 October). President Reagan stated that he felt compelled to act due to "concerns over the 600 U.S. medical students on the island" and fears of a repeat of the Iran hostage crisis, which ended less than three years earlier. According to the future United States Secretary of State Lawrence Eagleburger, who was serving as Reagan's Under Secretary of State for Political Affairs at the time of the invasion, the prime motivation for the US intervention was to "get rid" of the coup leader Hudson Austin, and the students were the pretext. While the invasion followed the execution of Maurice Bishop, his party members intending to gain power still maintained his communist ideologies. President Reagan expressed that he viewed this, alongside the party's growing connection to Fidel Castro, as a threat to democracy.

The invading force consisted of the 1st and 2nd battalions of the <u>US Army</u>'s <u>75th Ranger Regiment</u>, the <u>82nd Airborne Division</u>, and elements of the former <u>Rapid Deployment Force</u>, <u>U.S. Marines</u>, <u>US Army Delta Force</u>, <u>Navy SEALs</u>, and ancillary forces, totaling 7,600 troops, together with <u>Jamaican</u> forces and troops of the <u>Regional Security System</u> (RSS). [14] The force defeated Grenadian resistance after a low-altitude airborne assault by the Rangers and 82nd Airborne on <u>Point Salines Airport</u>, at the south end of the island, and a Marine helicopter and amphibious landing on the north end, at <u>Pearls Airport</u>. Austin's military government was deposed and replaced, with Scoon as Governor-General, by an interim advisory council until the 1984 elections.

The invasion was criticized by many countries. British Prime Minister Margaret Thatcher privately disapproved of the mission, in part because she was not consulted in advance and was given very short notice of the military operation, but she supported it in the press. The United Nations General Assembly condemned it as "a flagrant violation of international law" on 2 November 1983, by a vote of 108 to 9.

The date of the invasion is now a national holiday in Grenada, called <u>Thanksgiving Day</u>, commemorating the freeing of several political prisoners who were subsequently elected to office. A <u>truth and reconciliation commission</u> was launched in 2000 to re-examine some of the controversies of the era; in particular, the Commission made an unsuccessful attempt to find Bishop's body, which had been disposed of at Austin's order and never found.

The invasion highlighted issues with communication and coordination between the different branches of the American military when operating together as a joint force, triggering post action investigations resulting in sweeping operational changes in the form of the <u>Goldwater-Nichols</u> Act and other reorganizations.[17]

1900: Opening ceremonies: Invocation, Pow/Mia, Pledge of Allegiance, and preamble.

Meeting called to order at 1904 hours by Commander Cavalieri.

Roll call of Officers conducted: quorum met.







#### Get Reimbursed for Post-2010 Emergency Medical Expenses, Apply by February. 22, 2024

In 2023 the Veterans Administration (VA) announced that it had created a unique, one-year open period during which veterans enrolled in VA Health Care can apply for VA reimbursement of their emergency medical expenses at non-VA facilities for emergencies that occurred at any time after February 1, 2010 – that is, during the last 14 years. This right to a VA reimbursement decision applies even if the veteran was denied reimbursement or did not apply for reimbursement in the past. But VA has made clear that it will not decide whether the veteran is entitled to reimbursement unless the veteran files a reimbursement claim on or before February 22, 2024. To file a reimbursement claim, a veteran must complete and sign VA Form 10-583 and mail or deliver it to the nearest VA medical facility to where you live.

#### **VA Backlog**

Because of the VA's record increase in new claims, there has also been an anticipated increase in the number of claims applications that take longer than 125 days to process (otherwise known as the backlog). This was about 378,000 claims at the end of 2023. While the total claims inventory has been decreasing over the last several weeks, the backlog is expected to grow in 2024 before returning to normal levels. Although the backlog has increased, you may receive a benefits decision more quickly than during some of their previous surges: At the end of 2023, the average claim was processed by VA in 149 days, which was 198 days faster than in 2013.

Generally speaking, if you are under Medicare and unsure about what to do find yourself an independent insurance agent that deals with Medicare.

#### PACT Act - Those Left Out

The VA has always had something of a two-tiered system for handling help for those facing health consequences from their lives in and around the military. Some conditions are automatically accepted as tied to service allowing for a streamlined course for receiving benefits. But those who suspect their illnesses were caused by contamination from U.S. military installations aren't covered by the law. It's understandable that affected veterans are angry. At nearly every opportunity he gets, VA Secretary Denis McDonough tells former service members they should file claims for any injury or illness they believe is service-connected even if it is not an established presumptive condition. Unfortunately, without the presumptive connection to service for a medical condition, however, the pathway to receiving VA disability is an enormous challenge. The good news is the military services, Defense Department and VA are conducting or planning to launch studies on potential exposures at various locations where veterans have already reported problems. For example, Fort Ord was designated a Superfund site in 1991 by the Environmental Protection Agency for extensive contamination of its soil and groundwater. Even today, parts of the former installation are so polluted, they can't be redeveloped.

# TO GET REIMBURSED FOR POST-2010 EMERGENCY MEDICAL EXPENSES, VETS MUST APPLY TO VA BY FEB. 22, 2024

Last year, VA announced that it had created a unique, one-year open period during which veterans enrolled in VA Health Care can apply for VA reimbursement of their emergency medical expenses at non-VA facilities for emergencies that occurred at any time during the last 14 years (that is, after Feb. 1, 2010). This right to a new reimbursement decision applies even if the veteran was previously denied reimbursement or never applied for reimbursement in the past.

# But to be eligible for this new reimbursement decision, the veteran must apply to VHA for reimbursement on or before FEBRUARY 22, 2024.

To file a reimbursement claim, a veteran must complete and sign VA Form 10-583 and mail or deliver it to the nearest VA medical facility to where you live. You can get a copy of VA Form 10-583 at

<u>www.va.gov/communitycare/programs/veterans/file-a-claim.asp.</u> or <a href="https://www.va.gov/resources/reimbursement-of-non-va-prescriptions-or-medical-expenses/">https://www.va.gov/resources/reimbursement-of-non-va-prescriptions-or-medical-expenses/</a>

You can find the nearest VA medical facility to you at www.va.gov/find-locations/ The VA form must be **received** by the VA medical facility by the **February 22**, **2024 deadline**. If you decide to hand-deliver the form, get a VA employee to sign his or her name and date of receipt to the copy of your signed VA Form 10-583 that you keep for your records. If you decide to mail the completed VA form, it should be sent in a way that allows you to prove the date on which the medical facility received the form – for example, by Priority Mail, or Federal Express. To the extent possible, you should also include the following along with the completed form:

 a statement identifying the dates of the medical emergency care, and the name of the non-VA facility at which emergency medical care was provided;

- a copy of any invoices provided by the non-VA facility for the medical services;
- a copy of receipts of any payments you made for the non-VA medical services; and
- if Medicare, Medicaid or other private health care insurance covered part of the emergency expenses, a copy of any Explanation of Benefits or Medical Care Summary Notice prepared by these insurers.

You should keep a copy for your records of all the papers you provide to the VA medical facility.

The one-year open period for applying for reimbursement is an outgrowth of NVLSP's victory in the lawsuit *Kimmel v. Secretary of Veterans Affairs*. In that case, the U.S. Court of Appeals for the Federal Circuit invalidated the part of VA's reimbursement regulation that prohibited VA from reimbursing a veteran with private health insurance for the veteran's coinsurance liability not covered by insurance. In February 2023, VA announced the one-year open period to apply for reimbursement so that veterans who had emergencies in the past can take advantage of the favorable changes in the VA reimbursement system that have taken place over the last 14 years. **GET ADVICE**: During the last two years, did VA deny you reimbursement for emergency medical expenses you incurred at non-VA facilities? If so, NVLSP may be able to advise you on what to do about it. Contact us at reimbursement.help@nvlsp.org with the date of the VA denial letter, and, if possible, a copy of the denial letter.
